The Commission **suspends the licensee’s license for a total of two (2) days to be served. 

**DECISION**

Sand Dollar Bar & Grille Inc. dba Sand Dollar Bar & Grill (the "Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, §12. The Alcoholic Beverages Control Commission (the "Commission") held a hearing on Wednesday, December 10, 2014, regarding an alleged violation of M.G.L. c. 138 §69-Sale or Delivery of an Alcoholic Beverage to an Intoxicated Person (1 count). Prior to the commencement of the hearing, the Licensee stipulated to the violation alleged in Investigator Velez's Report.

The following documents are in evidence:

1. Licensee's Stipulation of Facts; and
2. Investigator Velez's Violation Report dated June 6, 2014.

There is one (1) audio recording of this hearing.

**FACTS**

1. On Friday, June 6, 2014, at approximately 10:50 p. m., Investigators Binienda, Kenny, Keefe, and Velez conducted an investigation of the business operation of Sand Dollar Bar & Grille Inc. dba Sand Dollar Bar & Grill, to determine the manner in which its business was being conducted.
2. At approximately 10:53 p.m., investigators' attention was drawn to a male individual, Chris (last name unknown.) who appeared to be intoxicated.
3. Investigators observed that Chris spoke with slurred speech, and that his eyes were watery, glassy, and bloodshot.
4. At approximately 11:01 p.m., investigators observed Chris swaying side to side as he stood next to a high top table while holding onto it for balance.
5. Investigators also observed that Chris appeared to be falling asleep while standing next to the high top table.
6. Investigators observed Chris stumble as he walked around the table to speak to his friend.
7. Based on their training and experience, investigators formulated the opinion that Chris was intoxicated.


8. At approximately 11:20 p.m., investigators observed Chris's friend order two drinks from the bar. Investigators observed the bartender on duty deliver two glasses of whiskey to the friend.
9. Investigators noted that Chris stood approximately three feet from the bar. in direct sight of the bartender.
10. Investigators then observed Chris take possession of the glass of whiskey, and consume it.
11. Investigators observed Chris and his friend exit the premises.
12. Investigators identified themselves to Chris and asked to see his identification.
13. Chris said, "This is bullshit" and he reached for the investigators' neck badge, trying to grab it.
14. Investigators noted that Chris was very aggressive and argumentative, and uncooperative with them.
15. Investigators learned that Chris and his friend were renting a house down the street and were walking home.
16. Investigators then spoke to the owner of the licensed premises, Terry O'Donnell, and identified Chris to him.
17. Mr. O'Donnell admitted that Chris was drunk and he had had too much to drink. Mr. O'Donnell provided safe transport home for Chris by calling a cab for him.
18. Investigators informed Mr. O'Donnell of the violation and that a report would be filed with the Chief Investigator for further action.

CONCLUSION

Based on the evidence, the Commission finds the licensee violated M.G.L. c. 138 §69-Sale or Delivery of an Alcoholic Beverage to an Intoxicated Person (1 count). Therefore, the Commission **suspends the license for four (4) days, of which two (2) days will be served and two (2) days will be held in abeyance for a period of two (2) years provided no further violations of Chapter 138 or Commission Regulations occur.**
