NOTICE OF SUSPENSION

September 15, 2016

After a hearing on September 13, 2016, the Commission finds Skelligs Calling LLC d/b/a O'Shea's Olde Inne on Cape Cod violated:

- 1) M.G.L. C. 138, § 69 Sale or delivery of an alcoholic beverage to an intoxicated person (1 count);
- 2) 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: 527 CMR 1.05, § 10.5.2.1 – Overcrowding or admittance of any person beyond the established posted occupant load shall be prohibited.

On the first violation, M.G.L. C. 138, § 69, the Commission **suspends the license for four (4) days of which two (2) days will be served and two (2) days will be held in abeyance for a period of two (2) years provided no further violations of Chapter 138 or Commission Regulations occur.**

On the second violation, 204 CMR 2.05 (2), to wit: 527 CMR 1.05, § 10.5.2.1, the Commission **suspends the license for eight (8) days of which two (2) days will be served and six (6) days will be held in abeyance for a period of two (2) years provided no further violations of Chapter 138 or Commission Regulations occur. This suspension to run concurrently with the one above. The Licensee will serve a total of two (2) days.**

The suspension shall commence on Wednesday, November 9, 2016 and terminate on Thursday, November 10, 2016. The license will be delivered to the Local Licensing Board or its designee on Wednesday, November 9, 2016 at 9:00 A.M. It will be returned to the Licensee Friday, November 11, 2016.

You are advised that pursuant to the provisions of M.G.L. c. 138 §23, you may petition the Commission to accept an offer in compromise in lieu of suspension within twenty (20) calendar days following such notice of such suspension. If accepted, you may pay a fine using the enclosed form, which must be signed by the Licensee and a Massachusetts Licensed Accountant.

You are advised that you have the right to appeal this decision under M.G.L. c. 30A to Superior Court within thirty (30) days upon receipt of this notice.

DECISION

SKELLIGS CALLING LLC D/B/A O'SHEA'S OLDE INNE ON CAPE COD
348 MAIN STREET
DENNIS, MA 02670

VIOLATION DATE: 03/17/2016

Skelligs Calling LLC d/b/a O'Shea's Olde Inn on Cape Cod (the "Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, §12. The Alcoholic Beverages Control Commission (the "Commission") held a hearing on Tuesday, September 13, 2016, regarding alleged violations of:

- 1) M.G.L. C. 138, § 69 Sale or delivery of an alcoholic beverage to an intoxicated person (1 count);
- 2) 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: 527 CMR 1.05, § 10.5.2.1 – Overcrowding or admittance of any person beyond the established posted occupant load shall be prohibited.

Prior to the commencement of the hearing, the Licensee stipulated to the violations alleged in Investigator Carey's Report.

The following documents are in evidence:

1. Investigator Carey's Investigative Report dated February 4, 2016; and
2. Licensee's Stipulation of Facts.
 - A. Cape Cod Times Article 8/21/2016;
 - B. Letter 7/9/2016 from Dr. Lawrence McAuliffe to Internal Revenue Service on behalf of owner Joseph Shea.

The Commission took Administrative Notice of the Licensee's Commission files.

There is one (1) audio recording of this hearing.

FINDING OF FACTS

1. On Thursday, March 17, 2016, at approximately 10:50 p.m., Investigators Kenny and Keefe ("Investigators") investigated the business operation of Skelligs Calling LLC d/b/a O'Shea's Olde Inne on Cape Cod to determine the manner in which their business was being conducted.
2. Investigators entered the licensed premises, and observed that the establishment was well over its capacity. Investigators each did a count of the crowd and came up with numbers close to 200 persons.
3. Investigators observed several individuals who appeared to be intoxicated. One individual, James, had slurred speech, bloodshot eyes, and at time his eyes were half-closed. Investigators observed James swayed from side to side. Based on their training and experience, Investigators formed the opinion that James was intoxicated.
4. Investigators observed James go up to the bar and order three Smithwick Draft Beers. James gave two of these beers to two individuals, and kept one beer for himself.
5. Investigators identified themselves to the owner, Joe Shea, and the bartender, Seamus Hanrahan, and pointed out James to them.
6. Mr. Shea acknowledged that there may have been people drinking too much but it was St. Patrick's Day and there was a lot of activity.
7. Investigators asked Mr. Shea what was the capacity of the licensed premises. Mr. Shea stated the capacity was 100 persons. Investigators informed Mr. Shea that he was well over that number.
8. Mr. Shea stated that he didn't think the capacity was that high. It was St. Patrick's Day and they were having a big night.
9. Investigators advised Mr. Shea that he ensure James would take a cab home, to which Mr. Shea agreed.
10. Investigators informed Mr. Shea of the violation and that a report would be submitted to the Chief Investigator for review.
11. As they exited the premises, Investigators noticed that the doorman had stopped allowing people to enter the premises and a line was forming.

CONCLUSION

Based on the evidence, the Commission finds the Licensee violated:


