### **FINAL DECISION**

Martin Suuberg, the Commissioner of the Massachusetts Department of Environmental Protection (“MassDEP” or “the Department”), has designated me as the Final Decision Maker in this appeal.

On April 29, 2022, the Petitioner and the Department filed a Joint Stipulation of Dismissal requesting dismissal of this appeal with prejudice. The Joint Stipulation of Dismissal constitutes a waiver by the Petitioner to any further administrative review before the Department as well as appeal to court of the Draft Waterways License, No. W21-6024 (“the Draft Waterways License”) issued by the Department on January 20, 2022. Accordingly, the Department issues this Final Decision incorporating the Joint Stipulation of Dismissal, making the Draft Waterways License a Final Waterways License, and dismissing this appeal with prejudice.
