THE COMMONWEALTH OF MASSACHUSETTS: NOTICE TO CONTRACTORS

The Department of Fish and Game, Division of Fisheries and Wildlife (MassWildlife) invites sealed bids for Exterior Work at the Western District Office (DFW-2025-041) located at 88 Old Windsor Road, Dalton, MA 01226, in accordance with specifications prepared by MassWildlife. The contract will consist of all labor, materials, equipment, and incidentals to replace existing rear deck with a landing and stairway and replace rotten logs on the log-cabin type building. All Work must be done between April 14, 2025 and completed no later than June 30, 2025. The estimated project value is **(\$55,000)**. General Bids shall be submitted on the forms furnished by MassWildlife in the bid package, and will be received at the MassWildlife Field Headquarters, 1 Rabbit Hill Rd, Westborough, MA, until 10:00 AM, local time, Friday, March 28, 2025, at which time they will be publicly opened and read. All bids must be submitted in accordance with the Contract Documents and shall be accompanied by a bid deposit in the amount of 5% of the value of the bid. Bid deposits, payable to the Commonwealth of Massachusetts, Division of Fisheries and Wildlife, shall be in the form of a bid bond, certified, cashier's or treasurer's check issued by a responsible bank or trust company. Contract Documents will be available after February 26, 2025, at www.commbuys.com. Enter DFW-2025-041 in the search bar.

Under M.G.L. Ch. 149, Sec. 44A, Part (C), every contract for the construction, reconstruction, installation, demolition, maintenance or repair of any building by a public agency estimated to cost more than \$50,000 and not more than \$150,000, except for a pumping station to be constructed as an integral part of a sewer construction or water construction project bid under the provisions of Sec. 39M of Ch. 30, shall be awarded to the lowest responsible and eligible general bidder on the basis of competitive bids in accordance with the procedure set forth in Sec. 39M of Ch. 30.

There is no pre bid-meeting, but Contractors may contact Western District Supervisor, Andrew Madden, 413-684-1646 to make arrangements to visit the site. Minimum wage rates for this project have been predetermined by M.G.L. under Ch. 149, Sec. 26 to 27, inclusive. Proposals that do not have the Affidavit (of non- collusion, etc.) properly completed will be declared informal. Bids are subject to provisions of M.G.L. Ch. 30, Sec. 39M and Ch. 149, Secs. 44A to 44J, inclusive. The right is reserved to waive any informality in or reject any or all proposals.





Instructions to obtain bid documents from Commbuys

1. Go to www.commbuys.com
2. At the top of the screen, click on the advanced search option



3. On the Advanced Search page, click the dropdown box and select bid solicitations.



4. In the Description Box type the project number: DFW-2025-041 OR enter the Commbuys bid number 112919 in the Bid Solicitation # field.
5. The bid results will be displayed. Click on the blue bid solicitation # to obtain the bid documents.
