THE COMMONWEALTH OF MASSACHUSETTS: NOTICE TO CONTRACTORS

The Division of Fisheries and Wildlife (MassWildlife) invites sealed bids for Tree Clearing and Mowing/Mulching at the Myles Standish State Complex in Plymouth and Wareham, MA. This project involves furnishing all labor and materials, tools and equipment to conduct clearing of White Pine and Pitch Pine trees on 125 acres at the Southeast Pinebarrens WMA, located in Plymouth, MA and to conduct mowing and mulching on up to 81 acres at the Maple Springs WMA, located in Plymouth and Wareham, MA. Project shall be completed in accordance with specifications prepared by MassWildlife for project DFW-2025-047.

A mandatory pre-bid meeting will be held onsite Tuesday, January 7, 2025, at 9:00 AM. All bids must be submitted in accordance with the contract documents and shall be accompanied by a bid deposit in the amount of 5% of the value of the bid. Bid deposits, payable to the Commonwealth of Massachusetts, Division of Fisheries and Wildlife, shall be in the form of a bid bond or certified, cashier's or treasurer's check issued by a responsible bank or trust company. Contract documents will be available after December 25, 2024, at www.commbuys.com, enter DFW-2025-047 in the description field under bid search.

The Estimated Project cost is \$480,000.00.

Complete project specifications may be obtained at www.commbuys.com. In the bid description box enter DFW-2025-047 and click Find It (see detailed instructions below).

Mandatory Bid Conference: 9:00 am, Tuesday, January 7, 2025, at 9:00 AM. Meet the DCR Myles Standish State Forest Headquarters Building, 194 Cranberry Road (off of Long Pond Road) in Carver.


Bid Deadline: Sealed Bids must be received, in writing, no later than Friday January 17, 2025 at 2:00 pm, at the MassWildlife Field Headquarters, 1 Rabbit Hill Rd, Westborough, MA, at which time they will be publicly opened and read.



Instructions to obtain bid documents from Commbuys

3. On the Advanced Search page, click the dropdown box and select bid solicitations.



- 4. In the Description Box type the project number: DFW-2025-047 OR enter the Commbuys bid number 545635 in the Bid Solicitation # field.
- 5. The bid results will be displayed. Click on the blue bid solicitation # to obtain the bid documents.
