THE COMMONWEALTH OF MASSACHUSETTS: NOTICE TO CONTRACTORS

The Massachusetts Division of Fisheries & Wildlife (MassWildlife) is soliciting bids to refinish the exterior of the Western District Office, 88 Old Windsor Road, Dalton, MA 01226. This project will consist of all labor and materials to refinish the exterior of the log cabin style Western District Office Headquarters building. The project includes surface preparation with media blasting and treatment, sealing and staining, and all other activities associated with restoring and protecting the building exterior.

The Estimated Project cost is \$30,000.00.

Complete project specifications may be obtained at www.commbuys.com. In the bid description box enter DFW-2026-061 and click Find It (see detailed instructions below).

Pre-Bid Conference: None, but a site visit is mandatory to verify measurements and familiarize themselves with the local conditions under which the Work is to be performed. To schedule a site visit contact Andrew Madden, Western District Supervisor at 413-684-1646.

Bid Opening: Written Quotes should be submitted using the Mandatory Bid Sheet provided with the RFQ no later than March 27, 2026 at 2:00 pm. Bids must be emailed to james.burnham@mass.gov. There is no formal bid opening.

The contract will be awarded to the lowest responsible and eligible bidder for the treatment described on the Mandatory Bid Sheets. The term "lowest responsible and eligible bidder" shall mean (1) the Bidder whose Bid is the lowest of those Bidders demonstrably possessing the skill, ability, and integrity necessary for the faithful performance of the work, and who meets the requirements set forth in M.G.L. c.149 sec.44 (2)(B) and not debarred from bidding under M.G.L. c.149 §44C; (2) and who shall certify that they are able to furnish labor that can work in harmony with all other elements of labor employed or to be employed on the work; and (3) who shall certify that all employees to be employed at the worksite will have successfully completed a course in construction safety and health approved by the United States Occupational Safety and Health Administration that is at least 10 hours in duration at the time the employee begins work, and who shall furnish documentation of successful completion of said course with the first certified payroll report for each employee.

MassWildlife reserves the right to waive any informalities in, or to reject any or all Bids, if it be in the public interest to do so.




Instructions to obtain bid documents from Commbuys

1. Go to www.commbuys.com
2. At the top of the screen, click on the advanced search option
