> MASSHEALTH TRANSMITTAL LETTER DHP-24 October 2003

TO: Day Habilitation Programs Participating in MassHealth

**RE:** Day Habilitation Program Manual (Revisions to Service Codes and Descriptions)

This letter transmits revisions to the service codes and descriptions in the *Day Habilitation Program Manual* to reflect the implementation of the Health Insurance Portability and Accountability Act (HIPAA) of 1996, as amended. The revised Subchapter 6 is effective for dates of service on or after October 16, 2003. Subchapter 5 (billing instructions) will be revised at a later date.

The Centers for Medicare and Medicaid Services (CMS) have revised the Healthcare Common Procedure Coding System (HCPCS) for 2003. New national service codes have been added, and MassHealth local service codes have been removed from the *Day Habilitation Program Manual*. Please note that you must use a modifier with some codes to accurately reflect the service provided. The attached Subchapter 6 contains codes with modifiers, where applicable.

# **Place of Service Codes**

Effective October 16, 2003, providers will no longer be required to use different service codes when billing for day habilitation services provided in a nursing facility. Providers are required to report on the claim form the place of service (POS) where services are provided. Using this POS code, the Division will automatically pay for such services in accordance with the applicable fee schedule of the Division of Health Care Finance and Policy.

Please note that the HIPAA-compliant CMS POS codes are different from the Division's POS codes. The attached crosswalk details which code set is to be used for different claim types.

Providers should refer to Subchapter 5 (billing instructions) of the *Day Habilitation Program Manual* for a complete listing of all allowable Division POS codes. For 837 Professional claims, please coordinate the Division's POS code list with the HIPAA-compliant CMS POS code list that is available at <u>http://cms.hhs.gov/states/posdata.pdf</u>.

# Day Habilitation, Low-Need

Effective for dates of service on or after October 16, 2003, the MassHealth local service codes for day habilitation, low-need (X2303 full day, X2300 three-quarter day, X2304 half day, X2305 onequarter day) have been replaced with HCPCS code **H2014** (skills training and development, per 15 minutes). Providers must bill in 15-minute units with a minimum of one unit and a maximum of 24 units allowed per attendance day.

# Day Habilitation, Moderate-Need

Effective for dates of service on or after October 16, 2003, the MassHealth local service codes for day habilitation, moderate-need (X2306 full day, X2301 three-quarter day, X2307 half day, X2308 quarter day) have been replaced with HCPCS code **H2014** with modifier **TF** (skills training and development, per 15 minutes; intermediate level of care). Providers must bill in 15-minute units with a minimum of one unit and a maximum of 24 units allowed per attendance day.

# Day Habilitation, High-Need

Effective for dates of service on or after October 16, 2003, the MassHealth local service codes for day habilitation, high-need (X2309 full day, X2302 three-quarter day, X2310 half day, x2311 onequarter day) have been replaced with HCPCS code **H2014** with modifier **TG** (skills training and development, per 15 minutes; complex/high tech level of care). Providers must bill in 15-minute units with a minimum of one unit and a maximum of 24 units allowed per attendance day.

# Day Habilitation, Supplemental Staffing

Effective for dates of service on or after October 16, 2003, the MassHealth local service code for supplemental staffing (X2325) has been replaced with HCPCS code **H2014** with modifier **22** (Skills training and development, per 15 minutes; unusual procedural services). Providers must bill in 15-minute units with a minimum of one unit and a maximum of 24 units allowed per attendance day. Please refer to Day Habilitation Provider Bulletin 2, dated November 1999, for complete instructions on how to use this service.

## Day Habilitation, In-Facility Services, 1:2 or 1:3 staff-to-participant ratio

Effective for dates of service on or after October 16, 2003, the MassHealth local service code for day habilitation in a nursing facility, multiple members, less than four members (X2327) has been replaced with HCPCS code **H2014** with modifier **U1** (skills training and development, per 15 minutes). Providers must bill in 15-minute units with a minimum of one unit and a maximum of 24 units allowed per attendance day. Please refer to Day Habilitation Provider Bulletin 3, March 2000, for complete instructions on how to utilize this service.

## Day Habilitation, In-Facility Services, 1:1 staff-to-participant ratio

Effective for dates of service on or after October 16, 2003, the MassHealth local service code for day habilitation in a nursing facility, individual member (X2326) has been replaced with HCPCS code **H2014** with modifier **U2** (skills training and development, per 15 minutes). Providers must bill in 15-minute units with a minimum of one unit and a maximum of 24 units allowed per attendance day. Please refer to Day Habilitation Provider Bulletin 3, dated March 2000, for complete instructions on how to use this service.

## Day Habilitation, In-Facility Services, Staff Transportation

Effective for dates of service on or after October 16, 2003, MassHealth local service code for transportation to a nursing facility (X2320) has been replaced with HCPCS code **T2003** (non-emergency transportation; encounter/trip). Providers must bill for this service per trip with a maximum of two trips per program day.

This service is allowable only for in-facility services when staff-to-participant ratio is 1:4 or more and the provider uses this code in combination with the community-based day habilitation service codes and modifiers (H2014 including use of modifiers TF and TG).

In-facility services for members with a staff-to-participant ratio of 1:1, 1:2, or 1:3 includes the transportation rate in the service code/modifier. Please refer to Day Habilitation Program Bulletin 2, dated November 1999, for complete instructions on how to utilize this service.
