DIGITAL PUBLIC SERVICE ANNOUNCEMENT (PSA) REQUEST FORM

The Massachusetts Department of Transportation's (MassDOT) Office of Outdoor Advertising (OOA) Public Service Announcement (PSA) Program is an initiative that provides access for federal, state, and municipal agencies with public awareness messages to outdoor advertising companies that hold OOA digital billboard permits across the Commonwealth.

Requirements:

- Organizations must be a federal, state, or municipal agency or affiliated with a Secretariat.
- Request Form must be signed off by a duly authorized governmental official.
- A new form must be submitted for each PSA and for each airing.
- Specify MONTH(S) and/or START and END date.
- Contact the Office of Outdoor Advertising for complete digital artwork specifications.
- Completed forms should be delivered at least 60 days prior to start date and sent to:
