This placard has been issued to you. You are the only person entitled to use it.	Es distintivu li foi kriadu pa bó. Bó é úniku autorizadu a uza-l.
You may use it in any vehicle you are operating or in which you are being transported.	Bu posi uza-l na kualker veíkulu ki bu sta kunduzi ó ki bu sta ser transportadu ne-l.
When the vehicle is parked, the placard must be hung from the rearview mirror with the identification number and expiration date visible from the front of the vehicle.	Óra ki veíkulu sta stasionadu, distintivu ten ki sta prindadu na spédju retrovizor ku númeru di identifkason y data di validason ki ta dá pa odja apartir di frenti di karru.
If there is no rearview mirror, place the placard on the dashboard with the identification number and expiration date visible.	Si ka ten spédju retrovizor, bu ten ki poi distintivu na kuadranti di manera ki númeru di identifikason y data di validadi ta parsi klaru.
The placard is to be displayed only when the vehicle is parked, not when it is in operation.	Distintivu ten ki pódu só óras ki veíkulu sta stasionadu, nón óra ki sta na operason.
A citation could be issued for obstructing the driver's view if the placard is not removed when the vehicle is in operation.	Kondutor podi dádu multa pa obstruson di vizon kazu é ka tra distitivu óra ki veíkulu sta en operason.

Is my placard permanent or temporary?	Nha distintivu é difinitivu ó tenpuráriu?
If the expiration date is in red ink, it is temporary, and you will need to reapply 30 days prior to the expiration date if you need additional time.	Si data di validadi sta ku tinta burmedju, el é tenpuráriu, y si bu mesti más ténpu, bu ten ki torna fazi pididu ti 30 dia antis di data di validadi termina.
If the expiration date is in black ink, it is permanent and will renew automatically.	Si data di validadi sta ku tinta pretu, el é difinitivu y é ta rinova automatikamenti.
The color of the expiration date on the placard tells you and law enforcement if your placard is temporary or permanent.	Kor di data di validadi di distintivu ta indika kondutor y autoridadis pulisial si bu distintivu é tenpuráriu ó difinitivu.
Wrongful use by any other person carries 60 day loss of license, placard revocation, \$500 fine for the first offense. \$50 fine for covering placard number/date.
