If the expiration date is in red ink, it is temporary, and you will need to reapply 30 days prior to the expiration date if you need additional time.	Si dat ekspirasyon an nan lank wouj la, li tanporè, e w ap bezwen re aplike 30 jou anvan dat ekspirasyon an si w bezwen plis tan.
If the expiration date is in black ink, it is permanent and will renew automatically.	Si dat ekspirasyon an nan lank nwa a, li pèmanan e y ap renouvle l yon fason otomatik.

Wrongful use by any other person carries 60 day loss of license, placard revocation, \$500 fine for the first offense. \$50 fine for covering placard number/date.
