

# DISTRICT 2 SNOW & ICE 2024 – 2025 EQUIPMENT INSPECTIONS

All equipment must be brought to a MassDOT Depot for inspection unless the vendor has **5 or MORE** pieces of equipment.

**Saturday October 19<sup>th</sup>, 7:00AM to 1:00 PM**

**Saturday October 26<sup>th</sup>, 7:00AM to 1:00PM**

**Saturday November 2<sup>nd</sup>, 7:00AM to 1:00PM\***

**Saturday November 9<sup>th</sup>, 7:00am to 1:00PM Re-inspections at West Springfield or Deerfield Depot Only**

- All vehicles should report with their plows and other accessories in working condition.
- **All vehicles must have a working Back-Up Alarm.**
- **All Combos and Tankers must have a working Closed Loop System and be calibrated.**
- **All Combos and Tankers must have a tracking GPS unit to pass Inspection.\*\***
- All plows and wing plows will be measured and tested.
- All safety lighting will be inspected and tested.
- All AWD vehicles will be verified and tested.
- All side saddle tanks may be filled with water, spray pattern verified and tested.
- All tankers may be partially filled with water, spray pattern verified and tested.
- **All vehicles must have a valid safety inspection sticker.**
- All reflectorized tape should be applied to vehicles and wings prior to the inspection.
- Wings require a Class 1 LED, and the top and bottom be outlined with retro-reflexive sheeting.
- **Hard hats and safety vests, should be available at time of the inspection.**

\*All vehicle inspections or re-inspections done after November 9<sup>th</sup>, 2024 will be ineligible for the Early Signing Bonus and the Extended Season Bonus.
