

# **DISTRICT 3 SNOW & ICE 2025 – 2026 EQUIPMENT INSPECTIONS**

The Depots will be staffed to perform inspections as follows:

**Monday October 20<sup>th</sup>, 8:00AM to 6:00 PM - Sterling Depot (14 Chocksett Rd)**

**Tuesday October 21<sup>st</sup>, 8:00AM to 6:00PM - Northborough Depot (138 Lawrence St)**

**Thursday October 23<sup>rd</sup>, 8:00AM to 6:00PM – Oxford Depot (58 Depot Rd)**

**\*\* Saturday October 18<sup>th</sup>, 7:00AM to 2:00PM – Worcester Headquarters (499 Plantation Pkwy)**

**\*\* Saturday October 25<sup>th</sup>, 7:00AM to 2:00PM – Worcester Headquarters (499 Plantation Pkwy)**

**\*\* Saturday November 1<sup>st</sup>, 7:00AM to 2:00PM – Worcester Headquarters (499 Plantation Pkwy)**

- All vehicles must report with their plows and other accessories in working condition.
- All vehicles must have a working Back-Up Alarm.
- All plows and wing plows will be measured and tested.
- All safety lighting will be inspected and tested.
- All Material Spreaders (Combos and Tankers) must have a working Closed Loop System.
- All side saddle tanks shall arrive filled with water, spray pattern verified and tested.
- All tankers shall arrive partially filled with water, spray pattern verified and tested.
- All vehicles must have a valid safety inspection sticker and vehicle registration.
- All reflectorized tape must be applied to vehicles and wings prior to the inspection.
- Wings require a Class 1 LED, and the top and bottom be outlined with retro-reflective sheeting.
- Hard hats and safety vests must be available at the time of the inspection.
- **Vehicles requiring GPS must have them working at the time of their inspection.**
