ATTENTION!

DISTRICT 4 SNOW & ICE 2024 – 2025 EQUIPMENT INSPECTIONS

Vehicle and safety inspections will be conducted as typical in prior years. Both the State Employee and Vendor should review the forms carefully to ensure they are completed accurately.

The Depots will be staffed to perform these inspections as follows:

Wednesday October 30th, 7:30AM to 4:00 PM Wednesday November 6th, 7:30AM to 4:00 PM Saturday November 9th, 6:00AM to Noon*

- All vehicles should report with their plows and other accessories in working condition.
- All vehicles must have a working Back-Up Alarm.
- All Combos and Tankers must have a working Closed Loop System and be calibrated.
- All Combos and Tankers must have a tracking GPS unit to pass Inspection.**
- All plows and wing plows will be measured and tested.
- All safety lighting will be inspected and tested.
- All AWD vehicles will be verified and tested.
- All side saddle tanks may be filled with water, spray pattern verified and tested.
- All tankers may be partially filled with water, spray pattern verified and tested.
- All vehicles must have a valid safety inspection sticker.
- All reflectorized tape should be applied to vehicles and wings prior to the inspection.
- Wings require a Class 1 LED, and the top and bottom be outlined with retro-reflexive sheeting.
- Hard hats and safety vests, should be available at time of the inspection.
- * All vehicle inspections or re-inspections done after November 9th, 2023 will be **ineligible** for the Early Signing Bonus and the Extended Season Bonus.
