

**MassDOT – District Five - 2023–2024 Snow and Ice Season**

District Five has scheduled **Vehicle and Safety Inspections** for all potential Snow & Ice Vendor Equipment.

The Depots will be staffed to perform these inspections as scheduled below:

(No owner-facility inspections will be performed on these dates)

**October 28<sup>th</sup> - Saturday 7:30am - 12:30pm**

**November 4<sup>th</sup> - Saturday 7:30am - 12:30pm** (also last Submission Deadline Date)

Below is a list of the MassDOT Depot Inspection Locations and Depot Contact Numbers. ALL VENDORS must arrive at a Depot with each prospective Snow and Ice vehicle with all attachments “plows/wings”, accessories, and safety equipment in working order. Other items include but not limited to; installed and functioning GPS (GPS is for material dispensing equipment only), safety lighting, reflective tape, hard hat and vest, valid inspection sticker, current registration and readable GVW Door tag, mandatory backup alarm, if applicable closed loop system/calibration/verify liquid functionality, provide a 24/7 contact phone number, and all other criteria as described in the current Agreement.

Only upon request by Vendors owning **FIVE (5) OR MORE** S&I Vehicles, MassDOT will provide for inspections to be performed at their facility. ALL equipment must be present and prepared for this **one-time** owner-facility inspection visit. MassDOT will not be responsible for scheduling or other conflicts if a vehicle misses the inspection or submission deadlines.

**REMINDER:** To be eligible to receive all applicable bonuses, Vendors are responsible to ensure that their individual vehicles and all associated accessories **PASS** the Vehicle and Safety Inspections (*including re-inspections*).

**ALL** Agreement paperwork must be **completed and submitted** to the Taunton District Five Office by: District Drop-Box, US Mail, or E-mail (*not to a Depot or Boston*). **DEADLINE DATES** are as shown on Page 7 of the current Agreement.

**NOTE:** MassDOT Depot staff may be entering this season’s Inspection data by electronic means (cell phone or tablet). If needed, the tradition Forms will be used and submitted to the District Office. If so, please retain the Pink Copy.
