

## **DISTRICT 6 SNOW & ICE 2025-2026 EQUIPMENT VENDORS**

The District has scheduled Vehicle and Safety Inspections for all District 6 Snow & Ice Hired Equipment. The Depots will be staffed to perform these inspections as follows:

**Saturday October 18<sup>th</sup>, between 6:00AM and Noon**  
**Saturday October 25<sup>th</sup>, between 6:00AM and Noon**  
**Saturday November 1<sup>st</sup>, between 6:00AM and Noon**

- All equipment must be brought to a MassDOT inspection Depot for inspection, **no exceptions**.
- All vehicles shall report with their plows and other accessories in working condition.
- All plows and wing plows will be measured and tested, must have a good cutting edge and functional trip edge.
- All safety lighting will be inspected and tested.
- All vehicles must have a valid safety inspection sticker
- All AWD vehicles will be verified and tested.
- All Combos and Tankers must have a working Closed Loop System and capable of treating 2 or more lanes.
- All side saddle tanks shall be filled with water, spray pattern verified and tested.
- All tankers may be partially filled with water, spray pattern verified and tested.
- All vehicles that fall under the OSHA regulations pertaining to reverse signal alarms. (Refer to 29 CFR 1926.601-602 for details) must be in working order.
- All reflectorized tape should be applied to vehicles and wings prior to the inspection.
- Wings require a Class 1 LED, and the top and bottom be outlined with retro-reflexive sheeting.
- Hard hats and safety vests should be available at time of the inspection.
- Installed and functioning GPS will be required for all Combos and Tankers. For GPS orders fill out the attached order form: [Proposal Request - MassDOT](#)

**\*\* All vehicle inspections or re-inspections done after November 1st, 2025 will not be eligible for the Early Signing Bonus or the Extended Season Bonus.**
