- Property Tax Exemptions Veterans Exemptions MDM-1 MVE Reimbursement
- The separate form for Paraplegic exemptions has been eliminated
- All Paraplegic exemptions are reported on the Veterans form only no need for a separate form
- All data already entered in the 2023 Paraplegic forms will appear in the Veterans form – no need to re-enter anything
- All communities submit two forms:
 - Veterans Exemptions
 - MDM-1
- You must submit the Veterans form before entering data on the MDM-1
