Two Important Announcements Related to Short-term Rental Revenue Reports and CPA DLS Data Analytics and Resources Bureau

Short-term Rental Revenues Report Available for Local Officials

Beginning with the September 30th room occupancy distribution, the DLS Data Analytics and Resources Bureau (DARB) can provide to local officials a breakdown of revenues by traditional lodging establishments (hotels/motels) and short-term rentals. Effective July 1st, 2019 the definition of "transfer of room occupancy" was expanded to include short-term rentals, and since that time local officials have been eager to know the split in these revenues.

DARB can now provide this important information to local officials working on behalf of a municipality by request. Please note that this information is subject to taxpayer confidentiality restrictions. Local officials seeking short-term rental revenue reports should email databank@dor.state.ma.us.

DARB also encourages communities to request a list of lodging establishments located within your community. If you would like a updated list of establishments, please send a request to databank@dor.state.ma.us.

Community Preservation Act (CPA) Updates and Reminders

Based on current Registry of Deeds collections, the base state match has been updated to 17.7% for FY2021. Accountants and assessors are also reminded to submit the CP-1 local surcharge report to be eligible for the state match in November. This form must be completed on the DLS Gateway application under Misc Forms, and is due by September 15th. Please note the 15th is also the due date for the Community Preservation Committee (CPC) inventory of CPA projects, which is entered on the CP3 application. Why Build a Cyber Incident Response Plan?

The National Cyber Incident Response Plan establishes that a cyber incident response plan "articulates the roles and responsibilities, capabilities, and coordinating structures that support how a municipality will respond to and recover from cyber incidents". The MassCyberCenter recommends the best action a municipality can take to improve their cybersecurity resiliency is to develop a cyber incident response plan, because through the planning process cities and towns will:

- 1. Prioritize the assets they need to protect;
- 2. Build a cybersecurity team;
- 3. Create processes to mitigate vulnerabilities; and
- 4. Raise awareness internally about the importance of cybersecurity.
