MassWorks 2020 Round Now Open

The Baker-Polito
Administration is pleased to announce the opening of the 2020 Round of the MassWorks Infrastructure
Program. All Massachusetts municipalities and public entities are eligible to apply for grants to support public infrastructure improvement projects.

MassWorks is a competitive grant program, administered by the **Executive Office of Housing** & Economic Development (EOHED) that provides capital grant funds for public infrastructure projects that support and accelerate housing production, spur private development, and create jobs throughout the Commonwealth. The deadline for applications, which will only be accepted electronically through an online portal, is August 28, 2020 at 11:59PM.

FY2020 Sewer Rate Relief Awards Gerry Cole - Bureau of Accounts Public Finance Section

In March, the Division of Local Services (DLS) announced the FY2020 distribution from the Commonwealth Sewer Rate Relief Fund, established in 1993 under the provisions of <u>Ch. 29</u>, §2Z of the Massachusetts General Laws.

This year, funds totaling \$1.1 million have been awarded to 44 Massachusetts governmental entities to mitigate sewer rate increases due to debt service obligations for qualified sewer construction projects.

DLS issued the annual program announcement and application form as Bul-2019-4 in September of 2019.

October 11, 2019 was stipulated as the requested date for submission of completed applications.

Applications were processed by DLS and the Department of Environmental Protection (MassDEP). MassDEP provided determinations of eligible indebtedness which is dependent upon the nature of a given project and its financing. The statute requires that eligible indebtedness be debt issued on or after January 1, 1990 which has a final date of maturity

FY2021 Telephone Company Central Valuations

Local boards of assessors will find the Fiscal Year 2021 telephone company central valuations pursuant to M.G.L. Chapter 59, Section 39 on the DLS website effective Monday, June 15, 2020. Also included is a memorandum to assessors about the FY2021 valuation as well as the valuation table used, the new growth figures and a list of company billing addresses.The Additional Landline Telephone Personalty by FCC Code for each of the centrally valued telephone companies by community is also available.

more than 5 years after the date of issuance and which is incurred to finance or refinance the cost of planning, design or construction of a water pollution abatement project. DLS and MassDEP require that a debt service schedule be submitted for any loan for which eligibility is requested.

Projects receiving state grants are ineligible and certain other projects have their eligibility defined in §2Z. After full review, only a small number of projects/debt service submitted was deemed ineligible. The Sewer Rate Relief Fund is distributed on the same pro-rata basis to all eligible applicants. This percentage is then applied to the total eligible debt service of each applicant to calculate the award.

Awards are legally capped at 20% of eligible debt service, but for many years, the distribution has been based on the amount appropriated by the Legislature. For FY2020, applications listing 340 project loans and debt service were approved and grants were awarded to:

- the Massachusetts Water Resources Authority
 (MWRA) = \$891,533
- 3 local water and sewer commissions = \$46,381
- 3 sewer districts = \$11,203
- 37 cities and towns = \$150,883

Since FY94, the sewer rate relief program has distributed over \$500 million to governmental entities throughout Massachusetts.

Assessors and City/Town Clerks Annual Assessing Staff Certification Bureau of Local Assessment

Gateway's Local Official's Directory (LOD) should be updated to reflect new personnel, if any, as well as updated election or appointment dates for existing personnel. Should there be no changes to report, the FY21 list may be certified at your earliest convenience.

Assessment managers/representatives are asked to review the list of assessment personnel generated with the information from the LOD to ensure all board members as well as support staff with valuation responsibility are correctly listed. After their review, they sign off on the list completing the first component of the certification of their assessment staff.

Assessment staff certification for both assessing managers and municipal clerks is completed through the DLS Gateway application and is accessible through the website: https://dlsgateway.dor.state.ma.us/gateway/Login. Once logged in, select the "Directory" tab, locate the menu "Assessor Management" on the left side of the screen and then select "Assessor Certification."

The assessing department's certification of personnel generates an email to their city/town clerk. The email informs the clerk that the assessor's role in the Certification of Assessing Staff is completed and requests they complete the final component of the certification process. Municipal clerks are asked to certify two key pieces of information contained in the list. They are asked to review the assessment personnel comprising the list as well as their associated dates of election or appointment. Additionally, they certify their administration of the oath for elected officials when applicable as well as the administration of the board of assessor's oath. Once the clerk's certification is complete, DLS will receive notification that the municipality's certification process is completed. New assessors and assistants who have not completed the required training will be sent a welcome letter. The letter will introduce the Division of Local Services and inform the assessor/assistant of the education requirements of the position and time frame they have in which to satisfy the
