RE: *Durable Medical Equipment Manual: HCPCS Update to Subchapter 6 and the MassHealth Durable Medical Equipment and Oxygen Payment and Coverage Guideline Tool*

Introduction

This letter transmits a revision to the service codes in the *Durable Medical Equipment Manual*. The Centers for Medicare & Medicaid Services (CMS) has revised the Health Common Procedure Coding System (HCPCS) codes for 2024. For dates of service on or after April 1, 2024, you must use the new code to receive reimbursement. [Administrative Bulletin 24-17](#) includes a full description and established rates for the added code.

The revised Subchapter 6 aligns with the list of service codes in the interactive [MassHealth Durable Medical Equipment and Oxygen Payment and Coverage Guideline Tool](#). For prior authorization requirements, service limits, modifiers, and allowable place-of-service codes, refer to the interactive tool. The rate regulation for durable medical equipment services is 101 CMR 322.00: *Rates for Durable Medical Equipment, Oxygen and Respiratory Therapy Equipment*.

601 Introduction

MassHealth pays for the services for codes listed in Section 602 in effect at the time of service, subject to all conditions and limitations in MassHealth regulations at 130 CMR 409.000 and 450.000. In addition, a provider may request prior authorization (PA) for any medically necessary durable medical equipment or supplies.

Providers should refer to the *MassHealth DME and Oxygen Payment and Coverage Guideline Tool* for service descriptions, applicable modifiers, place-of-service codes, PA requirements, service limits, and pricing and markup information. For certain services that are payable on an individual consideration (I.C.) basis, the tool can calculate the payable amount, based on information entered into certain fields on the tool.
