DECISION

DOUGLASPAK INC. D/B/A DOUGLAS VILLAGE PACKAGE STORE 392 NE MAIN STREET DOUGLAS, MA 01516

LICENSE#: 89114-PK-0288 VIOLATION DATE: 5/21/2024

Douglaspak Inc. d/b/a Douglas Village Package Store ("Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 15. The Alcoholic Beverages Control Commission ("ABCC" or "Commission") held a remote hearing via Microsoft Teams on Tuesday, August 20, 2024, regarding an alleged violation of 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Prior to the commencement of the hearing, the Licensee stipulated to the facts alleged in Investigators Gould & Kujawski's Minimum Purchase Age Compliance Check Field Report.

The following documents are in evidence:

- 1. Investigators Gould & Kujawski's Minimum Purchase Age Compliance Check Field Report, 5/21/2024;
- 2. ABCC Application Summary Review, Transfer of License Approved 7/24/2017;
- 3. Licensee's Stipulation of Facts.

FINDINGS OF FACT

- 1. On Tuesday, May 21, 2024, at approximately 4:36 p.m., Investigators Gould and Kujawski ("Investigators"), conducted a compliance check at Douglaspak Inc. d/b/a Douglas Village Package Store.
- 2. An underage operative working under the supervision of Investigators purchased an alcoholic beverage, one 25-ounce Natural Ice beer, for one dollar and eighty cents (\$1.80). The underage operative was not asked for identification.
- 3. The Licensee has held a license under M.G.L. c. 138, § 15 since 2017 with no previous violations.

CONCLUSION

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. As a result, the Commission issues a **WARNING**.
