DECISION

S & P RESTAURANT INC. DBA PARKER HOUSE GRILLE 101 BROADWAY RD. DRACUT, MA 01826 LICENSE#: 029200009 HEARD: 09/04/2012

S & P Restaurant Inc. dba Parker House Grille (the "Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, §12. The Alcoholic Beverages Control Commission (the "Commission") held a hearing on Tuesday, September 4, 2012, regarding an alleged violation of 204 CMR 2.05(2), to wit: c.138, §34. Prior to the commencement of the hearing, the licensee stipulated to the violation alleged in Investigator Bailey's Compliance Check Field Report.

<u>FACTS</u>

- 1. On Friday, May 4, 2012, at approximately 8:28 p.m., Investigators Doyle and Bailey conducted an investigation of the business operation of S & P Restaurant Inc. dba Parker House Grille.
- 2. An underage operative working with investigators was in possession of an alcoholic beverage, a bottle of Bud Light beer. The underage operative was not asked for identification.

CONCLUSION

Based on the evidence, the Commission finds the licensee violated 204 CMR 2.05 (2), to wit: M.G.L. c. 138, §34. Therefore the Commission suspends the license for three (3) days of which three (3) days will be held in abeyance for a period of two (2) years provided no further violations of Chapter 138 or Commission Regulations occur.
