## **DECISION**

SWAMIBAPAPANUAY, CORP. D/B/A MACKIE'S ALL IN ONE 391 TEXTILE AVE. DRACUT, MA 01826 LICENSE#: 029200042

VIOLATION DATE: 04/30/2016 HEARING DATE: 07/19/2016

Swamibapapanuay, Corp. d/b/a Mackie's All In One (the "Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, §15. The Alcoholic Beverages Control Commission (the "Commission") held a hearing on Tuesday, July 19, 2016, regarding an alleged violation of 204 CMR 2.05 (2) – Permitting an illegality on the licensed premises, to wit: M.G.L. c. 138, §34 – Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. Prior to the commencement of the hearing, the Licensee stipulated to the violation alleged in Investigator Bailey's Report.

The following documents are in evidence:

- 1. Investigator Bailey's Compliance Check Field Report dated April 30, 2016;
- 2. Licensee's Stipulation of Facts;
- 3. ABCC 2016 Compliance Check Guidelines; and
- 4. Photo of Underage Operative.

There is one (1) audio recording of this hearing.

The Commission took Administrative Notice of the Licensee's record.

## **FACTS**

- 1. On Saturday, April 30, 2016, at approximately 2:37 p.m., Investigators Doyle and Bailey ("Investigators") investigated the business operation of Swamibapapanuay, Corp. d/b/a Mackie's All In One.
- 2. An underage operative, working with Investigators, purchased from the Licensee an alcoholic beverage, a 12 ounce can of Budweiser Light beer, for one dollar and twenty-five cents (\$1.25). The underage operative was not asked for identification.

## **CONCLUSION**

Based on the evidence the Commission finds the Licensee violated 204 CMR 2.05 (2) - Permitting an illegality on the licensed premises, to wit: M.G.L. c. 138, §34 – Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. Therefore, the Commission suspends the license for three (3) days of which three (3) days will be held in abeyance for a period of two (2) years provided no further violations of Chapter 138 or Commission Regulations occur.
