Notice is hereby given that the Massachusetts Department of Environmental Protection (MassDEP), under authority granted by the Massachusetts Clean Waters Act, M.G.L. c. 21, §§ 26 – 53, and the implementing regulations at 314 CMR 3.00 and 4.00, is proposing to: (1) issue a federal Clean Water Act (CWA) Section 401 Water Quality Certification (WQC) for the U.S. Environmental Protection Agency's (EPA) proposed 2024 Draft NPDES General Permits for Small Municipal Separate Storm Sewer Systems (MS4s) in Massachusetts (Federal Permit) (MA Permit Nos. MAR041000, MAR042000, MAR043000), which will allow any "traditional" (i.e., cities and towns) and "non-traditional" (i.e., Federal and state agencies) MS4 operators in the Commonwealth of Massachusetts authorized by EPA under the 2024 Draft NPDES Federal Permit to discharge stormwater to the receiving water(s) as identified in the operator's Permit Authorization; and (2) issue the 2024 Draft Massachusetts Permit to Discharge Pollutants to Surface Waters (State Permit) for the same discharges pursuant to the Massachusetts Clean Waters Act. The proposed WQC, proposed State Permit, and proposed Federal Permit are all available at https://www.mass.gov/service-details/massdep-public-hearings-comment-opportunities. MASSACHUSETTS GENERAL PERMITS AUTHORIZING SMALL MUNICIPAL SEPARATE STORM SEWER SYSTEMS (MS4s) TO DISCHARGE POLLUTANTS TO SURFACE WATERS

In compliance with the provisions of the Massachusetts Clean Waters Act, as amended (M.G.L. Chap. 21, §§ 26 - 53) and the implementing regulations at 314 CMR 3.00 and 4.00, any operator of a small MS4 authorized by the United States Environmental Protection Agency (EPA), Region 1, to discharge under NPDES General Permit No. MAR041000 (Traditional Cities and Towns), MAR042000 (Non-Traditional MS4s), or MAR043000 (State transportation agencies except for MassDOT-Highway Division)¹, which together comprise the General Permits for Stormwater Discharges from Small Municipal Separate Storm Sewer Systems in Massachusetts ("2024 EPA MS4 Permit")², is authorized to discharge stormwater from that MS4 in accordance with the following conditions and requirements:

- This document consists of three (3) general permits listed below, each of which is applicable to a particular type of small MS4 within the Commonwealth of Massachusetts. These will collectively be referred to as "this permit" or "this MassDEP permit."
 - a. Traditional Cities and Towns (MA Permit No. MAR041000)
 - b. State, federal, county, and other publicly owned properties (MA Permit No. MAR042000)
 - c. State transportation agencies (except for MassDOT-Highway Division) (MA Permit No. MAR043000)
- 2. The issuance date of this permit is the date it is signed by the Massachusetts Department of Environmental Protection (MassDEP)³.
- 3. This permit shall become effective on [DATE]⁴.
- 4. This permit shall expire five years after the effective date.

¹ MassDOT Highway Division has requested to be covered under a Transportation Separate Storm Sewer System Permit (TS4). Until a TS4 Permit is implemented MassDOT Highway Division has coverage under the General Permit for Stormwater Discharges from Small Municipal Separate Storm Sewer Systems issued by EPA and MassDEP on April 18, 2003.

² This draft Mass DEP permit references the 2024 draft EPA MS4 Permit. The final version of this MassDEP permit will reference the final version of the EPA MS4 Permit. The final version of this MassDEP permit may reflect changes between the 2024 draft EPA MS4 Permit and the final version of that EPA permit.

³ Any person aggrieved by the issuance of this permit may file an appeal within 30 days of the issuance date. See Attachment A for further details on appeal rights and how to file an appeal.

⁴ According to 314 CMR 2.08(1), if no comments objecting to the issuance or terms of the permit were received by the Department during the public comment period, then the permit shall be effective upon issuance. If comments objecting to the issuance or the terms of the permit were received by the Department during the public comment shall become effective 30 days after issuance.

- 5. This permit supersedes the permits issued by MassDEP under Massachusetts law (jointly with the permits issued by EPA under federal law) on April 4, 2016, and modified on December 7, 2020 (collectively, "2016 MassDEP Permit").
- 6. Each MS4 operator seeking coverage under this permit must submit to MassDEP a copy of its Notice of Intent (NOI) submitted to EPA for coverage under the 2024 EPA MS4 Permit, which shall serve as the NOI for coverage under this permit. Instructions for submittal will be provided here: https://www.mass.gov/how-to/wm-15-npdes-general-permit-notice-of-intent. Compliance with those instructions satisfies the requirements of 314 CMR 3.06(4) for application for coverage under a MassDEP general surface water discharge permit. This NOI must be submitted to MassDEP within 90 days of the effective date of this MassDEP permit. An operator that submits its NOI to MassDEP as instructed and receives authorization by EPA to discharge under the 2024 EPA MS4 Permit pursuant to Section 1.7 of that EPA permit is authorized to discharge under this MassDEP is required.
- 7. Compliance with the requirements of this MassDEP permit is deemed to constitute compliance with 314 CMR 3.06(11) for entities required by 314 CMR 3.06(11)(b)1. to comply with 314 CMR 3.06(11). MassDEP may waive the coverage requirements of 314 CMR 3.06(11)(b)1. as specified in 314 CMR 314 CMR 3.06(11)(b)3. MassDEP may designate other entities to require coverage under this MassDEP permit as specified in 314 CMR 3.06(11)(b)2.
- 8. Pursuant to MassDEP's authority under M.G.L. Chap. 21, §§ 26 53, 314 CMR 3.00, and 314 CMR 4.00, this permit incorporates by reference the following sections of the 2024 NPDES General Permit for Stormwater Discharges from Small Municipal Separate Storm Sewer Systems in Massachusetts, issued by the United States Environmental Protection Agency (EPA), Region 1, and attached hereto by reference as Appendix 1and available on EPA's website at https://www.epa.gov/npdes-permits/massachusetts-small-ms4-general-permit. Note that certain permit terms and conditions are applicable to only a particular set of authorized entities.
 - Part 1.4 (Non-Stormwater Discharges);
 - Part 1.10 (Stormwater Management Program [SWMP]);
 - Part 2: Permit Conditions and Effluent Limitations;
 - Part 3: Permit conditions and Limits Specific to Non-Traditional MS4s;
 - Part 4: Program Evaluation, Record Keeping, and Reporting;
 - Appendix A: Definitions, Abbreviations, and Acronyms;
 - Appendix F: Requirements for MA Small MS4s Subject to Approved TMDLs;
 - Appendix G: Permit Monitoring Requirements for Discharges into Impaired Waters;

- Appendix H: Requirements related to discharges to certain water quality limited waterbodies;
- Appendix I: Required Illicit Discharge Detection and Elimination (IDDE) Program Components; and
- Appendix J: New Permittee Requirements to Reduce Pollutants to the Maximum Extent Practicable;

provided, however:

- a. that all stormwater discharges from an MS4 during the period of this permit, if the MS4 had coverage under the 2016 MassDEP Permit, do not constitute a "new or increased discharge" as defined in 314 CMR 4.02 and do not require an antidegradation review from MassDEP under 314 CMR 4.04.
- b. that stormwater discharges from an MS4 "new discharger" as defined in the 2024 EPA MS4 Permit, if the new discharger manages stormwater discharges in accordance with the applicable requirements of the Massachusetts Stormwater Handbook or more stringent standards imposed by municipal regulation or the 2024 EPA MS4 Permit, is presumed to be insignificant for the purposes of 314 CMR 4.04(2). Such discharge requires an antidegradation authorization pursuant to 314 CMR 4.04(5) from MassDEP only if the discharge is to an Outstanding Resource Water, as defined in 314 CMR 4.02 and identified in 314 CMR 4.06, or if MassDEP notifies the MS4 operator within 45 days of receiving the operator's NOI that an antidegradation review is required.
- c. that this permit is not intended to impose requirements of the Massachusetts Open Meeting Law (M.G.L. Chapter 30A, Sections 18-25) on activities not otherwise subject to those requirements.
- d. that a copy of the Annual Report described in Section 4.4 shall also be submitted electronically to MassDEP at the following email address: <u>stormwater.dep@mass.gov</u>.

SECTIONS OF EPA PERMIT INCORPORATED BY REFERENCE

MassDEP's SWDP incorporates the substantive requirements of the 2024 Draft EPA MS4 Permit, pursuant to MassDEP's authority under M.G.L. c. 21, §§ 26-53, 314 CMR 4.00, and 314 CMR 3.00, including but not limited to 314 CMR 3.06(11)(b)4.

ANTIDEGRADATION REQUIREMENTS

Paragraphs 8.a and 8.b of the MassDEP SWDP are intended to clarify and implement the MassDEP antidegradation requirements referenced in Parts 2.12(a) and 3.14 of the 2024 Draft EPA MS4 Permit, pursuant to 314 CMR 4.02, 314 CMR 4.04, and MassDEP's October 21, 2009, antidegradation policy (available at https://www.mass.gov/doc/antidegradation-implementation-procedures-0/download). Paragraph 8.a reflects the comprehensive nature of the requirements for existing dischargers under the 2024 Draft EPA MS4 Permit.

Clean Water Act Section 401 Water Quality Certification For the 2024 Draft NPDES General Permits for Stormwater Discharges from Small Municipal Separate Storm Sewer Systems (MS4s) in Massachusetts USEPA Permit Nos. MAR041000, MAR042000, and MAR043000

The Massachusetts Department of Environmental Protection (MassDEP), having examined the United States Environmental Protection Agency (EPA) – Region 1's 2024 Draft National Pollutant Discharge Elimination System (NPDES) General Permits for Stormwater Discharges from Small Municipal Separate Storm Sewer Systems in Massachusetts (Permit Nos. MAR041000, MAR042000, and MAR043000), issued November 22, 2024 (collectively, "2024 Draft NPDES General Permit"), hereby certifies that there is a reasonable assurance that the proposed discharge will not violate applicable Massachusetts water quality requirements, if made in accordance with the provisions of the 2024 Draft NPDES General Permit and the conditions set forth below, and provided that the 2024 Draft NPDES General Permit is not modified in a manner inconsistent with this certification:

The following conditions, together with the terms and conditions contained in the 2024 Draft NPDES General Permit, are necessary to ensure that the proposed discharges will comply with the applicable provisions of the Federal Clean Water Act Sections 208(e), 301, 302, 303, 306, and 307 and with appropriate requirements of State law, including, without limitation, the Massachusetts Clean Waters Act, M.G.L. c. 21, §§ 26-53, and the Massachusetts Surface Water Quality Standards published at 314 CMR 4.00.

a. That each new discharger (as defined in the 2024 Draft NPDES General Permit) shall obtain authorization from MassDEP pursuant to 314 CMR 4.04(5) if the new discharge is to an Outstanding Resource Water, as defined in 314 CMR 4.02 and identified in 314 CMR 4.06, or if MassDEP notifies the new discharger within 45 days of receiving the new discharger's Notice of Intent that an antidegradation review is required.
