Dear Mr. Gilleberto:

The Massachusetts Clean Waters Act (M.G.L. c.21, s.26-53) was amended by Chapter 246 of the Acts of 1973 to authorize the Massachusetts Department of Environmental Protection ("MassDEP") to regulate discharges into all waters of the Commonwealth, including groundwaters. MassDEP regulates discharges through the issuance of discharge permits which impose limitations on the amount of pollutants which may be discharged in effluent, together with monitoring and reporting requirements and other conditions to ensure adequate treatment of all liquid wastes prior to discharge.

MassDEP has reviewed your Notice of Intent (the "NOI") application for coverage under the General Permit for a Small Publicly Owned Wastewater Treatment Facility, submitted on March 9, 2018, on behalf of the North Reading High School/Middle School, located at 191 Park Street, North Reading, Massachusetts to discharge treated sanitary sewage from an existing on-site wastewater treatment facility, to the ground. MassDEP has determined that the NOI is complete and that the proposed facility complies with the requirements for coverage under the General Permit for General Permit for a Small Wastewater Treatment Facilities, BRP WP 81. Please refer to MassDEP's website at: http://www.mass.gov/eea/agencies/massdep/water/approvals/wastewater-forms.html for a copy of the applicable General Permit.

A decision regarding this NOI cannot be finalized at this time because of provisions in the Law regulating public notice of the proposed general permit coverage and opportunity for public comments and public hearing. Following receipt of comments on the public notice, and public hearing, if necessary,

the NOI will be finalized and MassDEP will issue its final determination to approve or deny the request for coverage.

Enclosed herewith is a copy of the public notice for your NOI. The enclosed public notice should be published to start the thirty (30) day public comment period.

In accordance with 314 CMR 2.06(4) and M.G.L. c.30A, the applicant or permittee, as applicable, shall publish public notice of the permit proceedings in *The Environmental Monitor*, a publication of the Massachusetts Executive Office of Energy and Environmental Affairs. The applicant or permittee shall submit to the Department a copy of the public notice as published in the *Environmental Monitor*, within seven days after the date of publication or at such other time as the Department requires. This information should be sent to the attention of Lisa Dallaire at the above letterhead address. The mandatory thirty day public comment period will commence with the date of publication of the public notice.
