TEMPORARY EMERGENCY CERTIFICATE APPLICATIONS (COVID-19): DISCUSSION:

TECs issued during COVID-19 Emergency will be expiring per 236 CMR 4.05(3) Temporary Emergency Certificate, which states that TECs "are valid for a period of six months and shall not

be renewed." Any public water systems with expiring TEC's may file an application with DPL for a six month Provisional Certificate per 236 CMR 4.05(4). Applications will be reviewed and evaluated by DPL. It should be noted that "Issuance of the provisional certificate does not relieve the water supplier from the responsibility of vigorously pursuing the goal of obtaining a fully certified operator of appropriate grade at the earliest possible opportunity."
