Annual Water Quality Reports: All you have to do is PRINT and SIGN!

Annual Water Quality Reports, also called Consumer Confidence Reports (CCRs), are due each year for Community (COM) systems on July 1st. While TNCs are not required to generate a CCR for their customers like COM systems, TNCs are required to post a CCR when it is made available by MassDEP. This is a reminder of MassDEP's Annual Water Quality Report for TNCs. MassDEP produces these reports on behalf of your establishment with data submitted over the previous calendar year. This ensures that smaller PWS are able to offer the same level of confidence to their customers as larger systems.

You can find the report online at: Public Water Supplier Document Search | Mass.gov. Documents are easily searchable by PWS name or PWS ID # through the drop-down menu. Click on 'retrieve documents' and several documents for your PWS will appear on the page such as your Certificate of Registration, Water Quality Report, and Compliance Monitoring Schedule. After you download and print your Water Quality Report, it must be signed by the owner and the certified operator before being posted in a conspicuous area for customers to see. Remember, MassDEP makes the report for you; all you need to do is print and sign!

Per- and Polyfluoroalkyl Substances (PFAS) Resources for Small Systems

Free Cybersecurity Assessment and Technical Assistance

With the US EPA, the Horsley Witten Group (HWG) is offering free and confidential, cybersecurity assessment and technical assistance to interested water and wastewater utilities. The assessment consists of a questionnaire completed with HWG staff, and the technical assistance consists of developing a cyber action plan based on the results of your utility's assessment focused on best practices to prepare for, respond to, and recover from a cyber incident. Adoption of these practices can reduce the likelihood that a cyber-attack will be successful and allows the utility to recover from any cyber-attacks faster and at a lower cost. Due to the COVID-19 pandemic, HWG is offering this assessment and technical assistance virtually.

US EPA Public Water Systems On-Demand Trainings

As an owner or operator of your water system, you should be familiar with the Massachusetts Drinking Water Regulations 310 CMR 22.00 as MassDEP is the primary enforcement authority under the federal Safe Drinking Water Act (SDWA). You are responsible for seeing that your system consistently meets state and federal drinking water quality standards. Compliance with the law provides your customers with added protection against waterborne disease.
