I. OLD BUSINESS

A request for extended services has been submitted and must be reviewed by the DSC based on the following criteria:

The scope of the proposed work covered by the extended service is substantially different than the originally advertised scope and the associated A/E fee is increased \$10,000 or more, or the construction budget for the proposed extended scope is \$100,000 or greater.
