Arlington HA 200-01 and 200-2 #010116 Budget: \$4,000,100 FEE: \$395,000

The Arlington Housing Authority, through the Massachusetts Department of Housing and Community Development (Department) is seeking the services of a qualified "Designer" within the meaning of M.G.L. Chapter 7C, Section 44, to provide professional design and construction administration services for a Phase I project. The project will take place at 21 residential buildings at the 200-1 development and 25 residential buildings at the 200-2 development in Arlington, Massachusetts. The 200-2 development will have a window replacement only. The 200-1 development will have a window replacement; envelope repair; a single, net zero/PHIUS certified, retrofit beta building; and an assessment to provide information for a PHIUS certified/net zero over time master plan to define future phases. The fee is only inclusive of Phase I.
