Dear Secretary Williams:

Pursuant to a directive of the Hearing Officer that Cox supplement its response to Information Request No. 2 and submit a Motion for a Protective Order by April 14, 2008, I have been working with the Company to obtain both the channel by channel basic tier programming costs and permission to file this information under seal with a Motion for a Protective Order.

At this time, my regional contacts have not yet been provided with channel by channel basic tier programming costs used to develop Form 1240 programming costs. I understand that Cox's corporate office in Atlanta is reviewing the information requested, the obligations under programming contracts to notify programmers of the request for this information and whether the Company can submit the requested information prior to satisfying its notice obligations under its programming contracts. I further understand that internal counsel at Cox's corporate office also is reviewing, among other legal issues, whether the requested proprietary information is required to be provided under the FCC's rate regulations where no increase in basic service rates has been requested by Cox.

For these reasons, I am unable to submit, on behalf of the Company and at this time, a supplemental response to Information Request No. 2 or a Motion for a Protective Order. I will advise the Hearing Officer of any change in this situation as soon as possible and will be prepared to further discuss this issue at the April 16, 2008 hearing if it remains an open issue at that time.

My office has received original tear sheets from the two newspapers that published the notice of hearing in this matter and as of today we had received an affidavit of publication from
