4. On average, I receive approximately 10 - 15 calls per dawweek/month/year from prisoners of correctional facilities in the Commonwealth.
5. I pay the phone company or its agent or affiliate for the above-described calls.
6. The cost of the above-described calls is very high, and I am petitioning the Department of Telecommunications (the "DTC") because I want the DTC to lower the rates I pay to receive calls from incarcerated clients.
7. The quality of the above-described calls is poor, and I also want the DTC to take some action to improve the quality of those calls.


