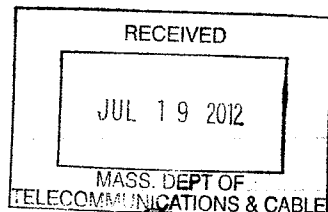


Dear Lizz:

MY NAME IS ROBERT ASSAN AND I AM A PRE-TRIAL DETAINEE AT THE DARTMOUTH HOUSE OF CORRECTION. I HAVE BEEN HERE SINCE JANUARY 3, 2012. UNFORTUNATELY THIS IS NOT MY FIRST TIME HERE. I - HAS BEEN BROUGHT TO MY ATTENTION THAT ON JULY 19, 2012 THERE WILL BE A HEARING ON THE RATE'S CHARGED FOR TELEPHONE CALLS FROM MASSACHUSETTS JAIL'S. I AM UNABLE TO ATTEND THE HEARING, BUT HOPE THIS LETTER WILL SERVE AS MY VOICE.

WHILE I AM HERE, MY FIANCEE IS WORKING A PART TIME JOB FOR MINIMUM WAGE AT A RHODE ISLAND DOLLAR TREE STORE TO SUPPORT HERSELF AND OUR TWO DAUGHTERS, AGES 3 AND 5. SHE HAS TO SHARE A TWO BEDROOM APARTMENT WITH HER FATHER AS FINANCES ARE TOUGH, TO SAY THE LEAST. AND BECAUSE SHE IS RESIDING IN FALL RIVER WHILE I AM HERE, SHE LOSES A PORTION OF HER PAY AS SHE HAS TO PAY TAXES TO BOTH MASS AND RI. THANKFULLY MY PARENTS OFFER HER FINANCIAL SUPPORT AS WELL.

AS YOU MAY ALREADY BE AWARE, TELEPHONE SERVICE AT THIS FACILITY IS PROVIDED BY SECURUS. THIS COMPANY HAS VERY LOUSY SERVICE, BOTH CALL QUALITY AND CUSTOMER SERVICE. I CALL HOME TWICE PER DAY, USUALLY, SO I CAN TALK TO MY FIANCEE DURING THE DAY AND AT NIGHT TO SPEAK TO OUR CHILDREN, AS THIS IS IMPORTANT. I ALSO RELY ON THE PHONE BECAUSE VISIT HOURS ARE FRIDAY 8:00 AM - 9:30 AM WHICH OFTEN IS THE HOURS MY FIANCEE WORKS AND WHEN OUR DAUGHTERS ARE AT DAYCARE. SO AS IS CLEARLY EVIDENT, THE PHONES ARE IMPORTANT. UNFORTUNATELY, AS A RESULT OF THE PHONE CALL RATES, THE CALLS HAVE BEEN BECOMING LESS FREQUENT. AS A RESULT OF THE CALLS BEING LESS FREQUENT, OUR CHILDREN'S BEHAVIOR AND EMOTIONAL ATTITUDE HAS CHANGED.

THE PRESENT RATE'S FOR TELEPHONE CALLS IS A TOTAL ABUSE OF THE AUTHORITY THE COMPANY AND SHERIFF'S OFFICE HAS OVER US. BECAUSE IT FALLS INTO EITHER PAY OUR PRICES OR DON'T MAKE A PHONE CALL. THIS IS CLEARLY EXTORTION. FOR ME TO MAKE AN IN-STATE CALL TO A 508 NUMBER COST'S ALMOST \$7.00 AND OUT OF 508, FOR EXAMPLE TO CALL MY FIANCEE'S CELL

PHONE (A 401 NUMBER) COSTS APPROXIMATELY \$37.00 FOR THE CALL. THIS IS NOT EVEN THE ^{27.00}LEAST BIT JUSTIFIABLE.

I AM PERPLEXED BY THE FACT THAT A TELEPHONE SERVICE CAN BE HAD FOR \$50.00 (\$45.00 THROUGH METRO PCS) WHICH INCLUDES TEXT, DATA, AND UNLIMITED INCOMING AND OUTGOING CALLING, YET THE CALLS FROM A JAIL, WHICH IS A SIMPLE CALL, COSTS SO MUCH. HOW IS THIS POSSIBLE?

IT IS MY HOPE THAT THE DEPARTMENT OF TELECOMMUNICATIONS AND CABLE WILL STEP IN AND FORCE THE REDUCTION OF THE COST OF A CALL. THE STATE OF RHODE ISLAND CHARGES \$1.85 FOR AN ENTIRE IN STATE CALL AND \$7.00 FOR AN ENTIRE OUT OF STATE CALL. THIS IS A LOT MORE REASONABLE. IT IS ALSO A LOT FAIRER TO OUR FAMILIES, FRIENDS, ATTORNEYS, ETC.

THANK YOU FOR TAKING THE TIME TO READ AND CONSIDER THIS LETTER.

DEAR LIZZ:

I RECEIVED THE INFORMATION REGARDING THE HEARING ON 7/19/12. PLEASE NOTE I AM NO LONGER AT ASH ST AS I WAS TRANSFERRED TO DARTMOUTH. THIS TRANSFER WAS A DIRECT RESULT OF AN OFFICER PASSING AROUND MY CRIMINAL RECORD AND NEWSPAPER ARTICLES ON ME.

I FILED A GRIEVANCE AT ASH ST REGARDING BOTH PHONE CALL RATES AND THE COST OF CANTEN ITEMS. TWO SEPERATE GRIEVANCES, ALTHOUGH BOTH CAME BACK WITH IDENTICAL RESULTS STATING EACH IS "A PRIVILEGE AND JAIL ADMINISTRATION CAN SET ANY RATE THEY CHOOSE". I APPEALED TO THE MATOR WHO DENIED THE APPEAL. WHAT A SURPRISE! I WOULD MAIL YOU THE PHONE GRIEVANCE BUT I MAILED IT TO THE NEW BEDFORD STANDARD TIMES (GIRI BROWN) AS PART OF A RESPONSE TO A RECENT ARTICLE HE WROTE. (I ASKED HIM TO RETURN IT AFTER HE HAS REVIEWED ALL THE INFORMATION I SENT.)

I AM ENCLOSING A LETTER WHICH I HAVE WRITTEN FOR THE DTC WHICH I WOULD LIKE YOU TO PRESENT TO THEM. I KNOW THERE ARE A LOT OF PEOPLE WHO ARE AFFECTED BY THIS PHONE ISSUE, BUT IT AMAZES ME HOW MANY OF THEM WOULD RATHER PLAY CARDS, WATCH A TV, OR EVEN SLEEP RATHER THAN WRITE A LETTER TO IMPROVE THING'S FOR US HERE. IT AMAZES ME HOW MUCH THESE PEOPLE ALL COMPLAIN ABOUT CONDITIONS HERE BUT WHEN THE TIME COMES TO QUITE POSSIBLY CHANGE STUFF, THEY ARE TOO BUSY, OR LAZY, TO TRY TO CHANGE IT.

I AM ALSO ENCLOSING A LIST OF INMATES WITH THEIR ID NUMBERS AND OUTSIDE CONTACT INFORMATION. THESE ARE INMATES WHO WANT TO BE INCLUDED IN THE ACTION. WE FIGURED THAT WE WOULD MAIL EVERYTHING TOGETHER TO ALLOW US TO SAVE

STAMPS.
