Petition of Recipients of Collect Calls from Prisoners at Correctional Institutions in Massachusetts Seeking Relief from the Unjust and Unreasonable Cost of such Calls

REQUEST FOR COMMENTS AND NOTICE OF CANCELLATION OF CASE STATUS CONFERENCE

On January 26, 2024, the Department of Telecommunications and Cable ("DTC") issued the Notice of Case Status Conference (the "Notice") requesting that interested parties provide the DTC with their availability for a teleconference to discuss relevant issues in connection with D.T.C. 11-16.

On February 23, 2024, the DTC received a response from Global Tel*Link Corporation d/b/a ViaPath Technologies providing availability for the parties and, further, recommending that parties provide written submissions in response to the topics listed in the Notice in lieu of or prior to conducting a case status conference. Securus Technologies, LLC likewise supported the submission of written comments.

Upon consideration, the DTC will cancel the proposed case status conference and request that interested parties provide written comments regarding whether:

- 1. Chapter 64 of the Acts of 2023 resolves concerns about ICS rates, ancillary service costs, and billing details such that the DTC should close that portion of its investigation. (see *Interlocutory Order*, D.T.C. 11-16 at 27-28 (June 14, 2016)).
- 2. The DTC's investigation into ICS service quality should be continued. (see id.).
- 3. The removal of payphones in public areas at correctional institutions unduly burdens newly released individuals and/or visitors of inmates.
- 4. There are any other developments regarding inmate calling services in Massachusetts that the parties believe the DTC should be aware of since the DTC's 2016 *Interlocutory Order*.

Parties are instructed to provide comments by March 28, 2024 and reply comments will be due by April 29, 2024.
