I am writing to request a six-day extension of (1) the deadline under 47 C.F.R. 76.933(g)(2) for the Massachusetts Department of Telecommunications and Cable (MDTC) to issue a Rate Order on rates proposed and implemented by Charter Communications (Charter) in its regulated Massachusetts communities, and (2) the one-year-period limitation of refunds under 47 C.F.R. 76.942 with respect to rates in the same communities. The MDTC received Charter's rate filing on November 4, 2015, establishing the current due date for the Rate Order as November 4, 2016. The requested extension would extend to November 10, 2016, the MDTC's deadline to issue a Rate Order and order refunds on Charter's rates. Charter, representatives of which are copied on this email, has assented to these extensions as the MDTC and Charter continue to explore the possibility of a voluntary settlement covering multiple MDTC dockets.
