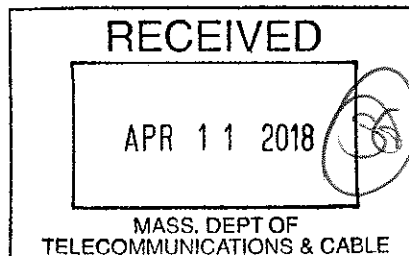


**TOWN OF WARWICK'S WITHDRAWAL OF COMPLAINT WITHOUT
