Kentucky	Granted 04/08/21
Maryland	Granted 03/31/21
New Jersey	Granted 04/27/21
South Carolina	Voted to grant 3/24/21, final order pending
Wyoming	Voted to grant 4/29/21, final order pending

The states that have issued final orders and imposed any significant conditions other than periodic reporting or other standard requirements are:

New Jersey — required Starlink, prior to beginning service, to provide a link to its rates, terms and conditions, and to submit a letter to the Staff and the Rate Counsel setting forth specified information on the terms and conditions of service for Lifeline customers. See Docket No. TO21010003, [Order 4-27-21-4B](#), dated 4/27/21.

Colorado — required reports on deployment every six months; a report of the status of its RDOF approval within 10 days after notification from the FCC; and reports if deployment milestones are not met. See Proceeding No. 21A-0023T, [Decision No. C21-0262](#), dated 4/30/21.

Second Supplemental Response to D.T.C. 1-2

As of May 7, 2021, one additional state, Vermont, has designated Starlink as an ETC. Other than periodic reporting or other standard requirements, the Vermont Public Utilities Commission has required Starlink to file with the Commission and Department of Public Service any FCC deployment milestone reports; file a marketing plan with specified information within 60 days; file an annual certification of its outreach efforts; and refrain from seeking any support from the Vermont Universal Service Fund unless it applies for additional authorization.
