MOTION FOR EXTENSION OF TIME

Pursuant to 220 C.M.R. 1.02(5), AirVoice Wireless, LLC d/b/a AirTalk Wireless (“AirVoice” or the “Company”) hereby files with the Massachusetts Department of Telecommunications and Cable (the “Department”) this Motion for Extension of Time. This Motion seeks a thirty day extension of time, from October 11, 2022 until November 10, 2022, to file responses to the Department’s first set of Information Requests issued on September 20, 2022 regarding AirVoice’s pending ETC application.

AirVoice will file responses to several of the Information Requests by the initial October 11, 2022 deadline. AirVoice seeks a thirty day extension of time to file the Information Request responses. Most of these Information Requests for which AirVoice requires a thirty day extension of time seek detailed financial information about the Company. Due to travel schedules, the persons responsible for developing such financial information have been out of the office and unable to complete the responses to these Information Requests. In addition, the responses to certain other Information Requests for which AirVoice seeks a 30 day extension of time require the cooperation of AirVoice’s underlying service providers. AirVoice has not yet been able to obtain from its partners all of the information necessary to provide complete responses.

For the reasons set forth herein, the Company submits that good cause has been shown for grant of this Motion for Extension of Time, and the Company respectfully requests that the Department grant this Motion to provide a 30 day extension of time – until November 10, 2022 – to file responses to the Information Requests - though AirVoice will file certain Information Request responses with the Department by the October 11, 2022 deadline.
