**DUA ADVISORY COUNCIL MEETING**

Thursday October 19, 2023  
Meeting Minutes

A virtual meeting was held via Zoom.

Motion was proposed to approve the September 2023 meeting minutes.

**Executive update**

Katie Dishnica, Director of DUA, provided an executive update.

The first update is that Paul Demakis recently retired from the Deputy Chief Counsel position. John Cronin will assume this role and will report to David Gold.

The second update is since the last advisory council meeting in September, the WBA increased to \$1033, effective October 2023.

The third update is regarding the redetermination regulations. A hearing occurred earlier this week. The next step is to review comments and bring back any revisions of the regulations to discuss at the November Advisory Council meeting.

The fourth update is regarding EMT. It is going well with over sixty-four thousand employers accessing the new system. After employers have filed their quarterly wages that are due at the end of October, DUA can start to focus on phase two of the EMT project, or the claimant side of unemployment. In order to launch the new system, enforcement was shut off. These include certified assessments for past due debts, court judgements, and levies. They have now been turned back on. This is slowly increasing, with only a little at a time being sent out to ensure it is functioning properly.

The fifth update is regarding Program Integrity. If you receive any questions, please point people to the advisory posted on mass.gov. There was an issue with constituents using a search engine to search for the unemployment website. Sponsored sites that are not valid DUA sites have been coming up in search results. Claimants should go to mass.gov to file an unemployment claim. DUA is working to get those fraudulent sites taken down. That has resulted in claims being hacked and the payment method being changed. There is a dedicated phone queue that has been created to work with claimants on this issue. There is an integrity symposium coming up in December that DUA will be attending. Information from this meeting will be shared at the January DUA Advisory Council meeting.

The sixth update is regarding tax intercepts. Tax intercept notices are sent out in October. DUA is working on removing claims that were reported as fraud from being sent a notice. This is just the intent notice. Claimants can request a review of the notice if they believe they should not have received the notice.

### **UI trust fund**

Lisa Hammerle, Director of the Department of Economic Research provided an update on the UI trust fund. The annual outlook report was sent on 10/15 and provided a status on the trust fund as well as projections for the 2023-2027 outlook period.

- YTD employer contributions through September 30 are \$738 million with a projected year-end total of \$852 million.
- YTD Benefit payments \$1.59 billion with a projected 2023 year-end total of \$2.08 billion
- The balance of the UI trust fund is \$3.22 billion, and the balance is projected to be \$2.87 billion.
- According to the projections DUA is looking at a Schedule C next year, and a D and E in the out years.
