DECISION

Square Corp. dba Halls Corner Store (the "Licensee") holds an alcohol beverage license issued pursuant to M.G.L. c. 138, §15. The Alcoholic Beverages Control Commission (the "Commission") held a hearing on Tuesday, March 17, 2015, regarding the alleged violation c. 138, §22 Transporting of alcoholic beverages without a valid permit. Prior to the commencement of the hearing, the licensee stipulated to the violation alleged in Investigator Kenney's Report.

The following documents are in evidence:

- 1. Investigator Kenny's Investigative Report dated August 5, 2014; and
- 2. Licensee's Stipulation of Facts;

There is one (1) audio recording of this hearing.

The Commission took Administrative Notice of the Licensee's record.

FACTS

- 1. On Thursday, July 3, 2014, at approximately 2:55 p.m., Investigator Kenny, and Chief Investigator Mahony, investigated the business operation Square Corp. dba Halls Corner Store to determine the manner in which its business was being conducted.
- 2. Investigators observed a vehicle pull up in front of the store. A male individual exited the vehicle and began to deliver cases of beer to the licensed premises.
- 3. Investigators observed that a total of 10 cases of Bud Light beer, and 5 cases of Budweiser beer were being delivered.
- 4. Investigators approached the male individual, Gino Benotti, identified themselves, and asked if he had a transportation permit.
- 5. Mr. Benotti stated he did not have a transportation permit, and that he was delivering the alcohol from Cape Way Convenience in Middleboro.
- 6. Investigators noted that Mr. Benotti drove a Ford Escape and that this vehicle did not have a transportation permit from the Commission.
- 7. Investigators spoke to the owner, Jay Patel, who stated that he was unaware that a transportation permit was needed to make a delivery.

8. Investigators advised Mr. Patel of the violation and that a report would be submitted to the Chief Investigator for review.

CONCLUSION

Based on the evidence, the Commission finds the licensee violated c. 138, §22 Transporting of alcoholic beverages without a valid permit. Therefore, the Commission suspends the license for three (3) days of which three (3) days will be held in abeyance for a period of two (2) years provided no further violations of Chapter 138 or Commission Regulations occur.
