- Ms. Read noted that by vote of the legislature, Public Meetings can continue to be held remotely until July 15, 2022.
- Mr. Maynard reported that the change to the Standard versions of the licensing examinations has reduced the number of question categories from ten (10) to five (5), and members discussed that candidates who fail the exam are not sure which categories to study, as score reports are less informative than before.
   Mr. Maynard also reported that he has received no answer from ABC to the Board's formal request for exam questions in the regulatory category.

### **DISCUSSION:**

<u>Request for Waiver</u>: A request for a "Waiver to Sit for Exam" (T4) was made by Chad Simones. After a discussion of the application waiver, the applicant doesn't meet the criteria for the waiver. A MOTION was made by Member Lukis and seconded by Member Coppes to deny the "Waiver to Sit for the Exam". Roll Call Board Vote: – Unanimous –Alfasso, Coppes, Lukis, Maynard, Reid, Salomaa In Favor.

Policy 94-01: Policy for Renewal Training Courses: Board discussed policy Section (IX), Distance Learning/On-line Training Approval. Pivotal issue is that the organization applying for remote training be able to verify the trainee by having a remote training policy in place. The Board previously provided and approved a "generic" or sample "Remote Training Policy". Applicants should have a similar on-line training policy in place. A policy that includes trainee verification should be submitted as part of the training course application package that is submitted by the organization to the Board for approval. The intent is to protects the integrity of the TCH training requirement. Draft Policy changes will be submitted to Board for review and approval.
