DPL UPDATE:

- Ms. Brann reported that DPL will require all Drinking Water Applications to be submitted online effective 6/30/21. Notice of change will be posted on DPL web site.
- Ms. Read reported that she is preparing regulations for final vote by Board and then review by appropriate DPL staff and the Secretariat.
- The DW Board will not be offering an extension for obtaining TCHs during the 12/31/2021 licensing period. There are a number of online training classes offering TCHs and the DW Board will continue to monitor the situation.

DISCUSSION:

Association of Boards of Administration (ABC) customer service representative Tom Healy gave a PowerPoint presentation on the current status of the MA operator exam.

- MA currently using the 2008 ABC customized exam.
- ABC Standardized exam was updated in 2019. A series of questions were eliminated from 2019 Standardized Exam; including but not limited to: SDWA Regulatory questions and a number of technical topics questions.
- Board discussed whether it was better to move the licensing exams from the current "ABC Customized Exam" to the "ABC 2019 Standardized Exam". Board Chair will do additional research and report back.
