- Chair is working with DPL to streamline online application processing:
- Member Reid and Maynard discussed status of ABC Exam question set. Customized Exam is the current exam for MA operators and is based on 2008 question set. The ABC Standardized Exam (2019) is based on "peer reviewed" question set.
- Iowa and Ohio Operator Certification programs have adopted the "ABC 2019 Standardized Exam". More information will be obtained and reported to Board.
- MOTION was made: To continue to evaluate the merits of the ABC Customized and ABC Standardized exams made by Member Coppes and seconded by Member Lukis. Roll Call Board Vote: Unanimous Alfasso, Coppes, Lukis, Maynard, Reid, Salomaa.
- Ms. Read reported that she prepared regulations for final vote by Board today and then review by appropriate DPL staff and the Secretariat.
- The DW Board will not be offering an extension for obtaining TCHs during the 12/31/2021 licensing period. There are a number of online training classes offering TCHs and the DW Board will continue to monitor the situation.

### **DISCUSSION**:

Association of Boards of Administration (ABC) customer service representative Tom Healy gave a PowerPoint presentation on the current status of the MA operator exam.

- MA currently using the 2008 ABC customized exam.
- ABC Standardized exam was updated in 2019. A series of questions were eliminated from 2019 Standardized Exam; including but not limited to: SDWA Regulatory questions and a number of technical topics questions.
- Board discussed whether it was better to move the licensing exams from the current "ABC Customized Exam" to the "ABC 2019 Standardized Exam". Board Chair will do additional research and report back.
