DISCUSSION:

The Board reviewed AWWA training policy that addressed online interactive "self-paced trainings". A self-paced training requires the participant to log into a web site and watch a series of short video modules about a specific drinking water related curriculum. The participant is then required to answer a series of questions about subject matter. The questions are used to reinforce the curriculum. The sessions are usually timed and will not allow the user to skip modules unless they answer the questions. This isn't a webinar.
