• Exam Score Required Timeline

Chair Celona reiterated that applications must be submitted within 6 months of passing the examinations, no deviations until the Regulations are updated.

• MWWA Operator Certification Q&A December event feedback

Board member Lukis spoke about giving presentations on the application process for Drinking Water certification and what applicants are expected to submit, available on YouTube.

Pre-requisite course waivers

Board Chair proposed eventual changes to the course waiver policy to include people with high school diplomas that have ten or more years of experience. This was followed by a discussion. It was requested that Board Chair analyze additional information and report back.

• WPI Exam Updates

Due to lower scores being reported nationally, WPI has developed new examinations with updated questions where the grading will be scaled. These examinations are intended to be the new standardized tests for the industry and existing examinations will be considered specialized tests. State Boards will need to make decisions regarding this when the time comes. More updates will be provided at future meetings as they come.
