#### **DOL UPDATE:**

• <u>Status of Draft Regulations:</u> Definition of "full-time" by the Board has been accepted and the draft regulations have been forwarded to the Secretariat.

- <u>Status of FAQ on Renewal:</u> License renewal FAQ has been published to the DW Board website.
- <u>Update on PSI testing center issues:</u> DOL is taking a multi-Board approach to reach out to PSI regarding these issues and will do so in the upcoming weeks.

## **DISCUSSION:**

- <u>Michael Retzky Appeal Board denial of D3-Full licensure</u>: Mr. Retzky appeared before the Board again and upon review of further information provided by the applicant, a MOTION was made by Member Celona and seconded by Member Alfasso to approve the application for D3 licensure. Roll Call Board Vote: – Unanimous – Alfasso, Coppes, Lukis, Reid, Salomaa, Celona in favor.
- <u>Dale Lynch Appeal Board denial of D1 Full licensure:</u> Mr. Lynch appeared before the Board to discuss his application. The Board had previously determined he had experience in a VSS system but not in a D1 system. There were no grounds for appeal under the Board's regulations and the license was properly denied.
- <u>Anthony Gulizia Appeal Board denial of D2 Full licensure:</u> Mr. Gulizia appeared before the Board to discuss his application. The Board determined he did not meet the experience requirements for D2 Full licensure. A MOTION was made by Member Coppes and seconded by Member Alfasso to deny the appeal for D2 Full licensure. Roll Call Board Vote: – Unanimous – Alfasso, Coppes, Lukis, Reid, Salomaa, Celona in favor.
- Board also briefly discussed the potential applicability of wastewater operator distribution experience towards a drinking water distribution license.
