DISCUSSION:

• <u>Jason Federico – Discussion of D2 Full application and T3 Full licensure</u> Mr. Federico appeared at the meeting and upon review and discussion of his applications and experience, the Board decided he would be approved for a D2-OIT later in the meeting.

• Robert Bott – Appeal Board denial of T4-Full licensure

Mr. Bott appeared before the Board and upon review of further information provided by the applicant, a MOTION was made by Member Coppes and seconded by Member Alfasso to grant the applicant waiver from training to sit for T1-T3 exams, allow applicant to sit for the T3 exam, and grant waiver from taking the T1 and T2 exams in succession before the T3 exam. Roll Call Board Vote: – Unanimous – Alfasso, Coppes, Lukis, Reid, Salomaa, Celona in favor.

• Discussion on Student Licensing – Ms. Sarah Cammer

Ms. Cammer discussed whether students in vocational training programs may take the examinations for T1 and T2 licenses. Board members and counsel discussed that OIT licenses do not require a high school diploma. The PSI exam administrator will not permit such students to take the exams, so Board staff will follow up with PSI.

• Training Contact Hours (TCH) Policy

Mr. Celona reported he had received written comments but had not yet created a new draft. He will bring the next draft to the Board at the next meeting.

• Exam waiver – Wahlstrom

After brief discussion, MOTION was made by Member Lukis and seconded by Member Coppes to approve the waiver requested. Roll Call Board Vote: – Unanimous – Alfasso, Coppes, Lukis, Reid, Salomaa, Celona in favor.

CORI Policy

Board Counsel Read discussed the updates made to DOL CORI Policy, going over new additions to sections I-IV. A MOTION was made by Member Reid and seconded by Member Alfasso to accept the revised CORI policy as presented and for the minutes to reflect that the Board accepted the Policy on the advice of Board Counsel. Roll Call Board Vote: — Unanimous — Alfasso, Coppes, Lukis, Reid, Salomaa, Celona in favor.

• Pre-Requisite courses for Reciprocity applications

The members discussed the need for a policy to address education requirements for licensees of other states that use different examinations and the need to maintain standards for applicants near state borders. No formal action taken.

• 2023 Audits

The Board has decided to conduct audits of TCHs obtained by licensees. DOL staff will figure out the logistics of this process and the audit will begin soon after license renewal period ends on December 31st, 2023.
