## **DCR-DWSP Deer Harvest Summary: 2023**

The Department of Conservation, Division of Water Supply Protection (DWSP) manages 140,000-acres across the Quabbin, Ware River, Wachusett and Sudbury Watersheds. Forest health and tree regeneration are important land management goals for DWSP because the forest acts as a biological filter for water quality. In response to high deer densities and deer impact on forest regeneration, DWSP opened watershed lands to deer hunting to restore and maintain balance in the forested ecosystem. These deer hunts are all regulated according to the Department of Fish and Game, Division of Fisheries and Wildlife's (MassWildlife) and DWSP's rules and regulations. Changes to the deer hunts may be applied annually based on an adaptive deer management approach. A few changes were applied to hunts in 2023: (1) Wachusett Reservoir Zone required a five-year watershed hunting access permit (instead of one-year access) and were open to all game species per MassWildlife and DWSP rules. (2) Petersham Zone at Quabbin was open for a two-day controlled hunt to permitted hunters for the first time since 2019. (3) Quabbin Park Zone was opened for the first time in the history of hunting at Quabbin Reservation. DWSP honored the winners of the 2019 Quabbin Park hunt lottery. (4) Hunters in the Ware River Watershed lands are now required to hold a five-year access permit. This was not strictly enforced in 2023.

The following DWSP hunting zones were open in 2023:

- Quabbin: Hardwick, New Salem, and Pelham Zones (two-week shotgun season deer hunts)
- Quabbin: Prescott, Petersham and Quabbin Park Zones (two-day controlled deer hunt)
- Ware River watershed lands (all seasons)
- Wachusett Watershed lands (including the Reservoir Zone; all seasons)
- Sudbury Watershed (all seasons)

Harvest data were analyzed from the MassWildlife harvest database (MassFishHunt). All hunters are legally required to submit their harvest information in-person at a check station or online to MassWildlife. DWSP biologists review the data and, based on information available, a list of confirmed and possible (unconfirmed) harvests on watershed lands is compiled. Due to the nature of the analyses performed, the 2023 DWSP harvest totals must be displayed as a range of deer harvested in each hunting zone (exception: Prescott, Petersham, and Quabbin Park Zones, where an in-person check station was present). The harvest analysis provided the following summary (confirmed number – total possible number) for 2023:

<u>Hardwick</u>: 14-15 deer
<u>New Salem</u>: 14-22 deer
<u>Pelham</u>: 7-10 deer
<u>Petersham</u>: 41 deer
<u>Prescott</u>: 40 deer

Quabbin Park: 37 deerWare River: no data

• Wachusett Watershed Lands, including Reservoir Zone (five-year permit): 6-96 deer

• Sudbury: 16-38 deer

In total, there were 175 confirmed harvests across all DWSP lands. The 2023 results by DWSP hunting area are further broken down in the table on the next page.
