## DECISION

KINNE & SONS, INC. DBA CITY LINE PACKAGE STORE 650 NORTH MAIN ST EAST LONGMEADOW, MA 01028

LICENSE#: 032800017

Kinne & Sons, Inc. dba City Line Package Store (the "Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, §15. The Alcoholic Beverages Control Commission (the "Commission") held a hearing on Tuesday, November 12, 2013, regarding an alleged violation of 204 CMR 2.05 (2) Permitting an Illegality on the licensed premises, to wit: c. 138 §34 Sale or Delivery of an Alcoholic Beverage to a person under twenty-one (21) years of age. Prior to the commencement of the hearing, the licensee stipulated to the violation alleged in Investigator Kujawski's Report.

The following documents are in evidence:

- 1. Licensee's Stipulation of Facts;
- 2. Investigator Kujawski's Compliance Check Field Report dated May 13, 2013;
- 3. Photo of Underage Operative; and
- 4. Can of Budweiser Light Beer.

There is one (1) audio recording of this hearing.

## **FACTS**

- 1. On Monday, May 13, 2013, at approximately 6:54 p.m., Investigators Keefe and Kujawski conducted an investigation of the business operation of Kinne & Sons, Inc. dba City Line Package Store.
- 2. An underage operative, working with investigators, purchased an alcoholic beverage, a can Budweiser Light beer for two dollars and forty cents (\$2.40). The underage operative was not asked for identification.

## **CONCLUSION**

Based on the evidence, the Commission finds the licensee violated 204 CMR 2.05 (2) Permitting an Illegality on the licensed premises, to wit: c. 138 §34 Sale or Delivery of an Alcoholic Beverage to a person under twenty-one (21) years of age. As the licensee has been in business for sixteen (16) years and has had no previous violations, the Commission issues a **WARNING**.
