Tudor House Discount Liquors Inc. ("Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 15. The Alcoholic Beverages Control Commission ("ABCC" or "Commission") held a remote hearing via Microsoft Teams on Tuesday, June 11, 2024, regarding an alleged violation of 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Prior to the commencement of the hearing the Licensee stipulated to the facts alleged in Investigators Gould & Kujawski's Minimum Purchase Age Compliance Check Field Report.

The following documents are in evidence:

- 1. Investigators Gould & Kujawski's Minimum Purchase Age Compliance Check Field Report, 3/18/2024;
- 2. ABCC Form 43, Transfer of License Approval, 6/30/1998;
- 3. Licensee's Stipulation of Facts.

FINDINGS OF FACT

- 1. On Wednesday, March 13, 2024, at approximately 5:42 p.m., Investigators Gould & Kujawski ("Investigators") conducted a compliance check at Tudor House Discount Liquors Inc.
- 2. An underage operative, working under the supervision of Investigators, purchased an alcoholic beverage, one 24-ounce can of Twisted Tea for three dollars and sixty-five cents (\$3.65). The underage operative was not asked for identification.
- 3. The Licensee has held a license under M.G.L. c. 138, § 15 since 1998 with no prior violations.

CONCLUSION

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Therefore, the Commission issues a **WARNING**.
