## **DECISION**

J & P INC. DBA PAPA GEORGE PIZZA 135 D NORTHAMPTON STREET EASTHAMPTON, MA 01027 LICENSE#: 036600049

VIOLATION DATE: 02/10/2014

J & P Inc. dba Papa George Pizza (the "Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, §12. The Alcoholic Beverages Control Commission (the "Commission") held a hearing on Tuesday, June 3, 2014, regarding an alleged violation of 204 CMR 2.05 (2) - Permitting an illegality on the licensed premises, to wit: c. 138, §34 Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. Prior to the commencement of the hearing, the licensee stipulated to the violation alleged in Investigator Keefe's Report.

The following documents are in evidence:

- 1. Licensee's Stipulation of Facts; and
- 2. Investigator Keefe's Compliance Check Field Report dated February 10, 2014.

There is one (1) audio recording of this hearing.

## **FACTS**

- 1. On Monday, February 10, 2014, at approximately 6:35 p.m., Investigators Kujawski and Keefe conducted an investigation of the business operation of J & P Inc. dba Papa George Pizza.
- 2. An underage operative, working with investigators, purchased an alcoholic beverage, a bottle of Budweiser Light beer for three dollars and twenty one cents (\$3.21). The underage operative was not asked for identification.

## **CONCLUSION**

Based on the evidence, the Commission finds the licensee violated 204 CMR 2.05 (2) - Permitting an illegality on the licensed premises, to wit: c. 138, §34 - Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. Therefore, the Commission suspends the license for three (3) days of which three (3) days will be held in abeyance for a period of two (2) years provided no further violations of Chapter 138 or Commission Regulations occur.
