May East Inc. d/b/a May East (the "Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 12. The Alcoholic Beverages Control Commission (the "ABCC" or "Commission") held a hearing on Wednesday, October 21, 2020 regarding four alleged violations. For violations of three COVID-19 Executive Orders, the Commission suspended indefinitely the license of May East Inc. until further written order of the Commission.

For the violation of 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: C. 138, § 34C Possession of an alcoholic beverage by a person under twenty-one years of age (5 counts), the Commission **SUSPENDED the license for a period of five (5) days with dates of said suspension to be determined by the Commission upon reinstatement of the license.**

The Commission issued a Memorandum and Order Reconsidering the Indefinite Suspension on December 14, 2020.

**The suspension shall commence on Monday, February 1, 2021 and terminate on Friday, February 5, 2021.** The license will be delivered to the Local Licensing Board or its designee on Monday, February 1, 2021 at 9:00 A.M. It will be returned to the Licensee on Saturday, February 6, 2021.

You are advised that pursuant to the provisions of M.G.L. c.138 § 23, you may petition the Commission to accept an offer in compromise in lieu of suspension within twenty (20) calendar days following such notice of such suspension. If accepted, you may pay a fine using the enclosed form which must be signed by the Licensee and a Massachusetts Licensed Accountant.

You are advised that you have the right to appeal this decision under M.G.L. c. 30A to Superior Court within thirty (30) days upon receipt of this notice.
